- Plockton Play Area
It looks like we may have it completed by next year.
- Village tidiness
Thanks to the donation from Plockton Harbour Ass and the good work by the Village Officer, the village continues to be fairly tidy. A recycling depot in Lochalsh is still required.

- Vandalism
We are pleased that there has been an improvement in the past year.
- Defibrillators
The village now has 2 so thanks to all who provided them
- New Hospital & Stromeferry Bypass
These will continue to be an item for many years.
- Service Point closure at Kyle
We hope Highland Council will have a rethink on closing this one.
- Planning Applications
Several have been discussed in the past few meetings but decisions are awaited.
- Village Clean ups
They continue to be a success if only for the provision of skips.
