- 1. Minutes of the last Meeting were proposed and seconded by I. Matheson and M. Jones, respectively.
- a) Police Matters The theft of a bicycle from the shed of a resident had been reported.
- b) Burnside Road Signs The CC expressed its satisfaction with the work carried out.
- c) Village Playpark Charitable status for this is now in place, and it is very much hoped that the work on the project can be progressed.
- d) War Memorials The Chairman had attended a meeting of the British Legion and the HC Chief Executive had agreed to fund and carry out the necessary work. S&L Tech Services had been approached re carrying out landscaping around the memorials.
- e) Bins A number of house-to-house visits to clarify the correct usage of bins have been carried out by the HC.
- f) Causeway Work on this area has started.
- g) Roads Work is needed in the areas behind the public toilets, around the Post Office and also on the road opposite Station House where there is a dangerous pothole. *Chairman to action*.
- h) All-weather Pitch The future management of this will be discussed at the AGM of the Lochalsh Sports Association.
- i) New Hospital A site for this facility is available at Broadford.
- j) Plockton Church Graveyard A quote for this work is awaited.
- k) Garden Area of Railway Station It was hoped that when the High School's timetable permitted, much-needed work on this area would be carried out.

l) Stromeferry Bypass – Once again problems have occurred with landslides, and it was agreed to contact the HC Transport, Environment & Community Services to express acute disappointment and concern at the lack of progress and the fact that the promised Options Proposal Report had still not been made available, the date for this having been given as July 2014. Also the Chairman agreed to follow this up with Cllr. Campbell.
