Also a fund for economic regeneration that might be able to give money for parking. Kate Stephen will contact MJ to arrange a meeting with person from council who will visit village to advise on parking

Austin Boyle was in attendance at the AGM. He mentioned that he has received complaints about the number of chairs in his Deli opposite the hall. His plan is for this to be a place that sells takeaway food with seats for eating in. It is not a cafe as no food is prepared on site. He is applying for new planing permission to be able to operate in this manner. He said that he doesn't envisage that he will be open for business this year.

At his building site at Rhu in Plockton, he currently has no end date for completion of the project. He has submitted a new planning application for the house and byre to be a B&B. There is a new planning requirement, something to do with rules for guest houses but Austin wasn't sure of the details, nor was anyone else. Austin admitted that the building site is unsightly but claimed his right to run his building project as he sees fit. He has no plans to remove any caravans from the site.

His house at No2 Bank Street, Plockton still has an outstanding planning issue in the design of his

modified front garden. He has no plans to change the garden and stated that he will go to court if he is required to change the work he has done to the garden.
