Plockton and District Community Council

Mr Mcghie,

I agreed to provide an update to the community council regarding the above matter once further internal HSE discussions had taken place. A further internal HSE meeting was held today and attended by the Principal Inspector for the area, Head of Operations for Scotland and Principal Inspector for HSE's agriculture/ livestock team.

As discussed previously, if it is necessary for cattle to be grazed within the village it is the livestock owner's responsibility to ensure that this is done without putting members of the public (and particularly high risk areas such as school grounds) at additional risk. I have now received confirmation from the crofter's involved that this will be achieved by installing temporary (electric) fencing around the area if cattle are grazed within the village. Therefore, cattle should only be outwith the fencing when they are being moved between grazing areas (within the village) and at this time they must be directly attended by the crofters. HSE deems these measures to be acceptable as long as they are effectively implemented and adhered to. However, if there is evidence that these measures are not being followed HSE would take formal enforcement action – this would likely be in the form of a Prohibition Notice.

I hope this provides clarity on the precautions that the crofters are required to take.
